JOURNAL ENTRY GRANTING APPLICATION FOR CHANGE OF LICENSE DESIGNATION FROM INACTIVE TO ACTIVE

On or about September 26, 2022, Shala R. Holman, P.A. ("Ms. Holman" or "Licensee") submitted an Application for Change of Designation/Type requesting her Inactive status be changed to Active. Such application was deemed complete and filed on January 11, 2023. On or about January 11, 2023, Disciplinary Panel #37, through Associate Litigation Counsel filed a Response in Opposition to Application for Change of Physician Assistant License Designation from Inactive to Active.

All parties were given notice of the Conference Hearing on Ms. Holman's Application for Change of Designation/Type in the above-captioned matter by the Kansas State Board of Healing Arts ("Board"), scheduled for Friday, February 10, 2023. No objection to the Notice of Hearing was filed.¹

¹ In advance of the oral arguments, the Board was provided the entire agency record to facilitate a comprehensive understanding of the underlying matter, including all exhibits, briefs, and motions filed by the parties in advance of oral arguments. The entire agency record was considered by the Board in rendering the decision.

The Conference Hearing in this matter was held before the Board on February 10, 2023.

Ms. Holman appeared in person, and through counsel, Tarak Devkota of Devkota Law Firm.

Disciplinary Panel #37 appeared by and through Bradley Taylor, Associate Litigation Counsel.

At the Conference Hearing, both parties provided oral argument. Additionally, Applicant

provided testimony supporting her application for change of license from Inactive to Active,

including testimony under oath that she was not actively practicing as a physician assistant while

her license was Inactive, and that her indication otherwise on her application materials was a

clerical mistake.

Upon conclusion of the hearing the Board did not find grounds for disciplinary action and

granted Ms. Holman's application for change of license designation from Inactive to Active and

such determination was reflected on the record as GRANTED, effective February 10, 2023.
