## JOURNAL ENTRY GRANTING LICENSE

On December 8, 2023, the Kansas State Board of Healing Arts ("Board") held a conference hearing to consider the Application for License to Practice Physical Therapy ("Application") for Akinsola Akinyode, P.T. ("Mr. Akinyode"). Mr. Akinyode appeared by video, *pro se*.

Pursuant to K.S.A. 77-506, the conference hearing was converted to a formal hearing for the purpose of receiving testimony from a non-party witness. Mr. Akinyode had no objection to conversion of the hearing and agreed that proper notice of the hearing conversion had been provided to him.

The Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record, the statements and arguments of the parties, hearing testimony, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

- 1. On or about August 2, 2023, Mr. Akinyode submitted an application for a Kansas physical therapy ("P.T.") license.
- 2. On or about November 17, 2023, the application was deemed complete and filed with the Board.

3. The Board finds that Mr. Akinyode meets the requirements for expedited state licensure under K.S.A. 48-3406:
