Journal Entry Reflecting Withdrawal of Application

All parties were given notice of the Conference Hearing in the above-captioned matter by the Kansas State Board of Healing Arts (“Board”), scheduled for Friday, February 9, 2024. No objection to the Notice of Hearing was filed.¹

The Conference Hearing in this matter was held before the Board on February 9, 2024. Danny R. Spoon, L.Ac. (“Applicant”), did not appear and has no attorney of record in this matter. C. Sebastian Orosco, Associate Litigation Counsel, appeared to present the position of Disciplinary Panel No. 38 (“DP #38”) of the Board.

During the hearing, Counsel for DP #38 made an oral motion requesting the Board issue a proposed default order under K.S.A. 77-520. As part of the motion, Counsel for DP #38 requested the Board delay issuing a proposed default order for two weeks to allow Applicant to file a request to withdraw his application.

The Board granted the motion for a delayed proposed default order and stated the order issuing the proposed default order would be held in abeyance for two weeks to allow Applicant to



file a written request to withdraw his application.
