**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW on this 14th day of October, 1995, comes on for consideration before the Kansas State Board of Healing Arts ("Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provision of K.S.A. 77-533 through 77-535 the application of James Richard Baker, M.D. ("Applicant") for licensure by endorsement to practice medicine and surgery in the State of Kansas. Lori Miskel McNett, Associate Counsel, appears for and on behalf of the Board. Applicant appears in person.

A protective order was issued on the transcript of these proceedings pursuant to K.S.A. 65-2836(i).

After reviewing the application and being otherwise duly advised in the premises, the Board finds as follows:

### **FINDINGS OF FACT**

1. On May 12, 1995, Applicant filed an application for endorsement to obtain a license to practice medicine and surgery in the State of Kansas.

2. Based upon information provided by Applicant in his application, the Board conducted an investigation into Applicant's affirmative answers to questions 10-14 of section VI of the application.

3. Based upon oral representations made to the Board at the conference hearing, the Board finds insufficient reason to believe that granting of Applicant's application for licensure would jeopardize the health, safety, and welfare of the citizens of Kansas.

### **CONCLUSIONS OF LAW**

Upon review of the application and the investigation results, the Board finds insufficient reason to deny Applicant's application for licensure by endorsement to practice medicine and surgery under K.S.A. 65-2836.

**IT IS THEREFORE BY THE BOARD ORDERED** as follows:

- a) That the findings herein above made be and the same are made the Order of the Board.
- b) That Applicant's Application for Endorsement in the State of Kansas should be placed on the Board agenda for final approval and issuance of a permanent license at the next regularly scheduled meeting of the Board.
- c) This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.




