FINAL ORDER TERMINATING PRACTICE MONITORING REQUIREMENT

NOW on this 12th day of June, 2015, comes before the Kansas State Board of Healing Arts (“Board”) the request filed by Sara Baskerville-Crome, D.C. (“Licensee”) to terminate the practice monitoring requirement contained in her Consent Order. Licensee appears in person, and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving exhibits into evidence, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of chiropractic in the State of Kansas, having been issued License No. 01-05005 on approximately December 10, 2005.
2. On or about February 24, 2014, Licensee entered into a Consent Order with the Board which was based in part on Licensee’s failure to maintain adequate patient records.
3. The Consent Order required Licensee to attend and successfully complete the in-person Medical Record Keeping Seminar offered by the Center for Personalized Education (“CPEP”).
4. Licensee completed the Medical Record Keeping Seminar on December 5, 2014.

5. The Consent Order also required Licensee to be subject to practice monitoring in the form of having a percentage of her patient records reviewed by another Kansas-licensed chiropractor for at least one year.

6. Between February 24, 2014, and May 11, 2015, the patient record reviews identified no problems with Licensee's patient record documentation.

7. The Board finds and concludes that Licensee has satisfactorily addressed the concerns with her patient record documentation and she should have no further obligation for compliance with the practice monitoring provision of the Consent Order.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Licensee's request to terminate the practice monitoring requirement in the Consent Order is hereby **GRANTED**.

IT IS FURTHER ORDERED that all other monitoring provisions contained in the Consent Order shall remain in effect.
