## FINAL ORDER TERMINATING MONITORING

NOW on this 10th day of April, 2015, comes before the Kansas State Board of Healing Arts ("Board") the request of Joel Erskin, PA ("Licensee") for termination of the monitoring requirement contained in the Consent Order filed on April 16, 2012. Licensee appears in person and by and through counsel Kevin Fowler of Frieden, Unrein and Forbes, LLP. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-28a01 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving evidence, and being otherwise advised in the premises, the Board makes the following findings, conclusions and order:

- 1. On January 30, 2015, Licensee submitted a request to the Board for termination of the monitoring provisions contained in the Consent Order.
- 2. On March 10, 2015, the Respondent Board filed a Response to Petition for Termination of Monitoring and included documentary evidence of Licensee's compliance with his monitoring requirements.

3. Based upon the documentary evidence submitted and arguments at the hearing, the Board finds that Licensee has satisfactorily met all requirements of the Consent Order and concludes that termination of the monitoring requirement is warranted in the circumstances.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF

HEALING ARTS that the monitoring requirements imposed by the Consent Order filed on

April 16, 2012, is hereby TERMINATED and that Licensee shall have no further obligation for compliance.

Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, et seq. Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the Final Order.
