**FINAL ORDER ACCEPTING WITHDRAWAL OF
APPLICATION FOR REINSTATEMENT OF LICENSE**

NOW on this the 12th day of April, 2013, comes before the Kansas State Board of Healing Arts (“Board”), the application of Glen David Georger, M.D. (“Applicant”) for reinstatement of licensure. Applicant appears in person and by and through his counsel, Brian J. Niceswanger of McDowell, Rice, Smith and Buchanan. Jessica A. Bryson, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and pursuant to the authority granted to the Board by K.S.A. 65-2801 *et seq.*, as amended, the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the file, hearing the testimony and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Applicant was previously licensed to engage in the practice of medicine and surgery in the State of Kansas, having been issued License No. 04-26782 on approximately April 5, 1997.
2. On approximately June 30, 2000, Applicant’s license was canceled for failure to renew.

3. On or about February 7, 2012, Applicant submitted an application to the Board for reinstatement of licensure to practice medicine and surgery in the State of Kansas. Such application was deemed complete and filed with the Board on January 11, 2013.

4. Applicant currently holds an active license to practice medicine and surgery in the State of Missouri.

5. On or about January 11, 2013, Board Counsel filed a Response in Opposition to Applicant's Application to Reinstate License to Practice Medicine and Surgery alleging violations of the Healing Arts Act.


6. At the conference hearing, Applicant expressed his desire to withdraw his application for reinstatement of licensure to practice medicine and surgery in the State of Kansas.

7. The Board finds that the allegations before them do concern Applicant's competency to practice medicine and surgery.

8. The Board concludes that withdrawal of Applicant's application is acceptable.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS, that Applicant's request to withdraw from consideration his application for reinstatement of licensure to practice medicine and surgery in the State of Kansas is hereby accepted.


