## FINAL ORDER GRANTING LICENSURE

**NOW** on this 23<sup>th</sup> day of January 2014, comes before the Presiding Officer, Kimberly J. Templeton, M.D., the application of Christian Heath, M.D. ("Applicant") for a license to practice medicine and surgery in the State of Kansas. Applicant appears in person and by and through counsel, Marta Fisher Linenberger of Foulston Siefkin, LLP. Reese Hays, Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act, the Presiding Officer hereby enters this Final Order in the above-captioned matter. After reviewing the agency record and evidence presented, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Presiding Officer makes the following findings, conclusions and order:

- 1. On or about October 30, 2013, Applicant submitted an application to the Board for a license to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on December 18, 2013.
- 2. Applicant graduated from medical school at Humboldt University in Berlin, Germany in May, 2003.

3. Applicant was engaged in postgraduate training in anesthesiology from

approximately September of 2004 through December of 2009 in Germany.

4. Applicant actively practiced medicine and surgery in Germany from

approximately December of 2009 through April of 2011.

5. Since approximately July of 2011 to present, Applicant has been engaged in

postgraduate training in anesthesiology at the Kansas University School of Medicine in Wichita,

Kansas.

6. K.A.R. 100-7-1(b)(1) requires that applicants for licensure by examination pass

all remaining steps of the United States Medical Licensing Exam ("USMLE") within a ten-year

timeframe of passing Step 1.

7. Applicant passed all required steps of the USMLE on his first attempt of each

step. However, more than ten (10) years elapsed between the time Applicant passed Step 1 and

Step 3. Applicant passed Step 1 in August of 2000, Step 2 in September of 2003, and Step 3 in

March of 2013.

8. Applicant's delay beyond ten (10) years in taking Step 3 was due to Applicant's

active practice of medicine in Germany. When Applicant decided to return to the United States

to enter a postgraduate training program in Kansas, Applicant discovered that he was beyond the

ten-year timeframe to take Step 3.

9. The Board approved Applicant to take Step 3 out-of-time in March of 2013.

10. The Presiding Officer finds that Applicant's education, extensive postgraduate

training and successful passage of each USMLE step on his first attempt warrant good cause to

waive the ten-year requirement to pass all three steps of the USMLE.

11. The Presiding Officer concludes that Applicant should be granted licensure by examination.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby granted a license to practice medicine and surgery in the State of Kansas.
