FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 10th day of December, 1994, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board") sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the application submitted by Lien Ai Hung, M.D. (hereafter "Applicant") for an institutional license, submitted November 23, 1994.

Charlene K. Abbott, Licensing Administrator, appeared to present information to the Board. Applicant appeared in person pro se and with Dara Johnson, M.D. from Larned State Hospital, Larned, Kansas.

After reviewing the request and being otherwise duly advised in the premises, the Board finds follows:

1. On November 23, 1994, Applicant filed an Application For Institutional License to practice medicine and surgery in the State of Kansas.

2. As part of that application, Applicant provided evidence of completion of all curriculum to graduate from Ho Chi

Minh University School of Medicine, Vietnam, but could not receive a diploma due to her leaving Vietnam in June, 1979 to seek political asylum. Ho Chi Minh University and its predecessor has been in operation for more than 15 years and has had graduates licensed in other states.

3. Subsequent to leaving Vietnam, Applicant enrolled at and attended Universidad CETEC for four trimesters and received a medical diploma from that institution in December, 1983. CETEC has since discontinued operation and since it was not in operation for 15 years it is not an approved school.

4. Since receiving a diploma from CETEC, Applicant completed a four-year psychiatry residency at St. Elizabeths Campus, Washington, D.C., holds an ECFMG certificate which is valid indefinitely and has passed Component II of FLEX.

5. Although Applicant cannot provide direct verification of graduation from Ho Chi Minh University School of Medicine, the successful completion of additional courses taken at CETEC, obtaining an ECFMG certificate and passage of Part II of FLEX, are all indications that Applicant did so graduate.

6. That from the documents provided by Applicant, the Board finds that Applicant meets the requirements for an institutional license and should be issued such upon providing proof of her employment by the Department of Social and Rehabilitation Services at Larned State Hospital.

IT IS THEREFORE ORDERED that the findings here and above made be and the same are made the order of the Board.


IT IS FURTHER ORDERED that an institutional license be issued to Applicant upon the Board being provided with proof of employment as specified in K.S.A. 65-2895.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
