COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about February 13, 2018, Licensee entered into a Consent Order with the Board for concerns regarding advertising professional superiority, advertising to guarantee a professional service or perform any operation painlessly, conduct likely to deceive, defraud, or harm the public, and willful or repeated violations of the Kansas Healing Arts Act. The Consent Order imposed a fine of \$750.00 and required Licensee to attend Board-approved ethical advertising courses and write an essay discussing the topics covered in the courses.


2. The Board record reflects that Licensee has completed all terms of the Consent Order and has no further obligation for compliance with the Consent Order.


